Executive Director (ED) Ayerdi-Kaplan congratulated Director Lloyd for being honored at the Western Railway Museum for his many years of hard work and advocacy for rail. She also reported on the success of Prop G which was overwhelmingly passed by 84% of San Francisco voters who once again reaffirmed that the Transbay Transit Center at First and Mission Streets is the desired terminus for High Speed Rail. She then reported on work to date including but not limited to the progress of Pelli Clarke Pelli Architects' work on the construction documents; meetings with various agencies including Amtrak, SF Fire Department, Department of Building Inspection, Planning Department, Redevelopment Agency, and Caltrans; continued work with Evans Brothers on the demolition planning to begin the construction efforts; updates regarding Utility Relocation; progress of the Temporary Terminal punch list work and the status of the Essex Street transit lane improvements; continued coordination with MTC Staff for the TransLink connections; and the successful meeting convened with Greyhound regarding their move to the Temporary facility.

Nancy Whelan, TJPA Financial Consultant, presented the Funding Update.

ED Ayerdi-Kaplan announced that the targeted move date for the operators to move operations from the current Terminal to the Temporary Terminal is Saturday, August 7<sup>th</sup>. She further announced that the groundbreaking will occur sometime after that date. Then, Robert Beck, Senior Program Manager, and Courtney Lodato, Public Relations Consultant, presented the Public Outreach Update.

Thomas Soohoo, Webcor/Obayashi Small Business Manager, presented the CMGC SBE Update.
