Refer to Specification Section 00 04 54 BUSINESS TAX REGISTRATION DECLARATION, which states: "I understand that if I am awarded the Contract, each of my subcontractors and I must maintain a current business tax registration number. If Contractor or TJPA determines that any of my subcontractors or I do not have or maintain a current business tax registration number, Contractor may either cancel the Contract or withhold payment."
