3. Approval of Meeting Minutes: December 12, 2023

4. Office of Community Investment and Infrastructure (OCII) update on the former Temporary Transbay Terminal parcels (Blocks 2, 3, 4) (15 minutes)

7. CAC Member Comments & Future Agenda Requests

Secretary Larrick noted that Agenda Item 4 fulfilled the previous request for "Office of Community Investment and Infrastructure update on the former Temporary Transbay Terminal parcels and its future uses" and would be removed from the Future agenda request list.

Member Patterson requested that OCII return and give an update on Block 4 before OCII decides to extend a future option to Hines .

Members Schatmeier and Nachor requested an update from AC Transit on their 2024 Realign service plans.

ED Van de Water noted that there is already a future request for San Francisco Municipal Transportation Agency (SFMTA) to provide a service update so it would make sense to combine service updates from both AC Transit and SFMTA for a future meeting.

Member Robinson announced that the East Cut Crossing would be hosting an official San Francisco 49ers watch party on January 21.
