Jim Patrick expressed his approval of the new signage at the west end of the facility. He also reported that he has researched the cost of private armed security compared to the San Francisco Police Department that the Transit Center utilizes and suggested that TJPA could realize a substantial savings by switching.

Jim Patrick stated that he disagreed with the terms of TJPA's Project Labor Agreement and believes that it is a violation of fiduciary responsibility to pay the highest price for labor.

Roland Lebrun stated that he was having audio difficulties. He suggested that TJPA review the engineering and funding for the Gateway Project occurring on the East Coast, stating that it is 70% funded by the Federal government and is the equivalent of the Pennsylvania Avenue Extension, the Portal, and Link21 combined.
