












Uses of Contingency this period

Additional costs for temporary facilities, civil scope transfer from TG12.1 to TG07.6, electrical changes to accommodate converged IP network needs, bus fountain shoe blast criteria revisions and fountain piping seismic support, Muni plaza changes, MEP no fly zones, First, Fremont, and Mission Streets traction power; and flashing beacon and barrier work, buried concrete conflict at Bus Storage area.






