Re: Project Labor Agreement Status Report

The Project Labor Agreement (PLA) for the Transbay Program was approved on November 10, 2011. The PLA is designed to ensure labor harmony and equal opportunity for small, local, disadvantaged, union, and non-union businesses throughout construction, providing standardized working conditions and wages. This quarterly report provides information on the status of the administration of the PLA and the apprenticeship plan that was developed in conjunction with the PLA.

PROJECT LABOR/LABOR HARMONY/ ACCESS TO SKILLED LABOR POOL

No work stoppages or labor incidents have affected construction on the project. The Construction Manager/General Contractor (CM/GC) Webcor/Obayashi and its trade subcontractors have reported no issues accessing skilled labor in sufficient numbers, and each trade subcontractor's workforce demands have been met.

A breakdown of labor by trade and county of residence compiled through September 30, 2019, by Turner Construction, the TJPA's construction management oversight consultant, for the monthly construction update is shown in the two tables that follow:

Final Reports on Apprenticeship Programs/Utilization and Veterans Outreach Efforts

Charley Lavery, Operating Engineers Local Union No. 3 (OE Local 3), reported that the number of OE Local 3 members working on the project to date has been unprecedented, and OE Local 3 has the highest percentage of women compared with other trades. It was noted that because of the TJPA's commitment to veterans on the Program, the OE Local 3 board approved a \$5 initiation fee for veterans (rather than the usual \$900); as a result, many veterans have joined.

Discussion on PLA status post Webcor/Obayashi Joint Venture Final Completion

The intent of the Project Labor Agreement (PLA) is to cover all Transbay Program public works for both Phase 1 and Phase 2 construction as well as tenant improvement work during Phase 1 construction. Phase 1 construction will be complete when Webcor receives Final Completion. Once that milestone is achieved, there will be a lag before Phase 2 construction begins. All current leases with tenants at the transit center reference the PLA and labor harmony and the TJPA has proposed to have the PLA and labor harmony language incorporated into future leases with union support received from the attendees. This item will be discussed further at the next JAC meeting.
