1. Call to Order



Chairman Nevin called the meeting to order at 9:48 a.m.

-Transbay Terminal/Downtown Extension Project Schedule -FY04 and FY05 Budget

Executive Director Ayerdi will present a final budget for approval at the next meeting. The final design for development has been given to the public. The engineering RFP has been published for industry review and will be formally issued in December.

Proposition K, extending the $\frac{1}{2}$ cent sales tax, passed on November 4th. It contains monies for the terminal project. We look forward to the passage of Regional Measure 2 in the March 2004 election.

A letter of interest was submitted to the FHA in November. The environmental materials were also submitted and their approval is expected by early 2004.

John Eddy reviewed the project schedule and tasks to be done over the next few months.

Director Burns asked about the funds for the project as it greatly impacts the schedule. Mr. Eddy noted that the project funds and schedule haven't been fully integrated yet. Director Burns asked if staff is assuming that in a year all the fund sources will be identified. Mr. Eddy noted that several of the sources, such as Regional Measure 2, are external events and dependent on the voters. If the various measure pass, those funds will be linked to specific tasks. Director Burns

noted that while it's good to have a schedule, staff needs to keep in mind that they can't plan too far out without securing the money to complete the project.

Nancy Whelan presented the TJPA budget. The estimate for the entire project is just over \$2 billion, which includes a 3% annual expansion factor. Many different sources of funds will be used. In addition to voter approved measures, there will be operating revenues, passenger facility charges, leveraged lease transaction and loans that will be repaid from tax increment monies.

The FY03 budget estimates \$156,000, mainly for consulting contracts. The FY04 proposed budget totals \$2.8 million that includes 7 months of staff and expenses. The FY05 budget is estimated at \$24.3 million. Revenues for FY03 and 04 will be federal demonstration grant and toll bridge reserves. Staff expects to be in the engineering and design phase by FY05 and the funding source for that year is still being identified. Regional Measure 2 funds will be used if the measure passes. Ms. Whelan also reviewed the status of various contracts.

Director Harper asked for a breakdown of the City Attorney's fees.

Director Burns asked for a cash flow analysis based on funds that are certain for the next three fiscal years when the budget is next presented to the board.
