Executive Director (ED) Ayerdi-Kaplan reported on work to date, noting that a number of milestones have been accomplished in 2011 including demolition of the old terminal, over 55,000 hours of labor without any injuries or issues, and commencement of construction for the new facility. She expressed gratitude to the staff, consultants, contractors and men and women on the construction site for all their good and hard work.

ED Ayerdi-Kaplan introduced Mike Grisso of the San Francisco Redevelopment Agency to report on the most recent bid received for one of TJPA's parcels. She reminded the Board that the State Department of Transportation transferred twelve acres to the TJPA and the City & County of San Francisco for the purpose of developing and using the proceeds to fund the new transit center. Mike Grisso reported on the bid received for Blocks 6 and 7. He stated the successful \$30 million dollar bid came from the team of Golub Real Estate Corporation and Mercy Housing California. He further stated the Golub Mercy team submitted a very ambitious

and exciting proposal working with the design team of Solomon Cordwell Buenz and Santos Prescott which are both local firms. He discussed the mechanics of next steps and expressed enthusiasm about the proposal and its positive effect on the project.

Sara Gigliotti, TJPA Chief Financial Officer, presented the Quarterly Financial Reports.

Paul Farnsworth and Aimee Arrigoni, William Self Associates, presented the Archaeology Presentation.

Steve Rule, Turner Construction, presented the Construction Update.
