- 5. Executive Director's Report
  - Construction Update

Executive Director (ED) Ayerdi-Kaplan announced that on April 26, 2012 TJPA received a plaque acknowledging its status as a new member in the Calmentor program. Calmentor is a mentor-protégé program that Caltrans has established to help increase the participation of small Architectural and Engineering firms in public transportation projects in the Bay Area region. She also reported that the team is working to finalize the 100% Construction Documents by Fall and provided the status of issued bids noting that the Geothermal Loop and Grounding System were issued on April 3 with bids due on May 17 and the Below Grade Substructure is expected to be issued on May 14 with bids due about July 11.

Bob Beck, TJPA Senior Program Manager, presented further on the specifics of the packages currently issued and upcoming that ED Ayerdi-Kaplan announced.

Scott Boule, Legislative Affairs and Community Outreach Manager, reported that upcoming community meetings are scheduled on May 21 at 5:30 p.m. for the Bus Storage Facility and May 30 at 12 Noon for the regularly scheduled monthly community meeting both at the TJPA office.

Bob Beck, TJPA Senior Program Manager, presented the Construction Update.

Jim Patrick, Patrick & Co., provided comments on the Transit Center District Plan (TCDP) and expressed concerns regarding a disadvantage to affordable housing, office tenants, and regular housing. He then stated his concerns with accessibility to the park and made budgetary suggestions.

Chair Kim noted that the TCDP is currently being heard at the Planning Commission, where comments can be made, and the final EIR certification and plan adoption will be heard on May 24.
