Executive Director Ayerdi-Kaplan reported on work to date including the success of the Beale street bridge installation. She also provided an update on the negotiations of the structural steel bid received from Skanska and indicated that Webcor/Obayashi sent a letter rejecting Skanska's bid as they were unable to reach a fair and reasonable price during negotiations. The structural steel package will be repackaged into four packages which will be brought to the Board at the May meeting for the cast nodes and June or July meeting for the three structural steel fabrication and erection packages.

Sara Gigliotti, TJPA Chief Financial Officer, presented the Quarterly Financial Reports.

Robert Beck, TJPA Senior Program Manager, and Ted Huang of Webcor/Obayashi presented the Quarterly PLA Report.

Steve Rule, Turner Construction, presented the Construction Update.

6. Public Comment

Jim Patrick, Patrick & Company, provided a West End Exit proposal.

Rick Smith, Yerba Buena neighborhood resident, expressed he was concerned about the budget increase and the steel contract. He then stated he was appreciative of staff's diligence in regards to value engineering, managing the project timeline, taking advantage of funding opportunities, and paying attention to safety. He also expressed his appreciation for staff's presentations. He was grateful for the public outreach, the display of artifacts, communications with staff and himself, and for the 10-day look-ahead notice. He also appreciated the Board's oversight.

8. Presentation of TJPA FY2013-14 annual budget outlook pursuant to Board Policy No. 003.

Sara Gigliotti, TJPA Chief Financial Officer, presented the item.

Directors Harper and Reiskin expressed concerns about paying for Caltrans lawyers' monthly parking and asked if there was an opportunity to renegotiate that clause of the Cooperative Agreement. Executive Director Ayerdi-Kaplan stated parking changes could be achieved through State legislation.

Director Reiskin suggested the Small Business Enterprise percentage be reviewed to ensure a low target is not set due to following the Federal Transit Administration's methodology which limits the DBE percentage.
