- 5. Executive Director's Report
  - Construction Update

Executive Director Ayerdi-Kaplan reported that the steel bid package was split into three packages and put back out to bid with bids due on June 20th and recommendation to the Board anticipated at the July 11th meeting in order to stay on schedule. She also stated 100% CDs are on schedule to be delivered by Pelli Clarke Pelli Architects on May 31st with the IT components coming later.
