Chair Nuru called the meeting to order at 9:35 a.m.

4. Board of Director's New and Old Business

- 5. Executive Director's Report
 - State Legislative Update

Executive Director Zabaneh reported that the San Francisco County Transportation Authority (SFCTA) awarded \$5.4 million of Prop K funds on April 25, 2017 to fund Phase 2/Downtown Rail Extension (DTX) activities. He also reported that formal negotiations are underway with the transit operators for their fair share contribution of the annual operating costs for the Transbay Transit Center (TTC). He provided an update on the TJPA Board's invite to the California High Speed Rail Authority (CHSRA) to join the TJPA Board and stated that the CHSRA Board would consider accepting the invite at their June 14, 2017 meeting. He noted that the Metropolitan Transportation Commission (MTC) Plan Bay Area includes significant funding for Phase 2 from future bridge tolls, and he also reported that discussions are ongoing with MTC to utilize Regional Measure 3 (RM3) funds for TTC operations costs. He introduced new TJPA staff members Martha Velez as Facility Manager, Sidonie Sansom as Chief Security Officer, and

Skip Sowko as Senior Design & Engineering Manager. He also acknowledged Scott Boule who was moving on to accept other work and thanked him for his years of service.

Niccolo DeLucca, Townsend Management, provided the State Legislative Update.

Director Reiskin stated that the City through the San Francisco Municipal Transportation Authority and the SFCTA would be formally taking a position on preferences for RM3 and would be supporting TJPA. Director Kim confirmed that SFCTA made a recommendation on its first reading to include including operating funds for TJPA in its RM3 allocation.

Chair Nuru expressed his appreciation to Scott Boule and he welcomed the new staff.

6. Citizens Advisory Committee (CAC) Update

Bruce Agid, TJPA CAC Chair, thanked Scott Boule for his work on the project and for his role on the CAC. He indicated the CAC was pleased with SFCTA's approval of funds to advance Phase 2. He stated the CAC was disappointed about the 7 week slippage noted in the construction update. He also stated the CAC was pleased with the Asset Manager's retail presentation. He noted that a brief discussion was had regarding homelessness and that the CAC looks forward to a future presentation on a proactive approach to address the issue.

Jim Patrick suggested considering a press release stating the TJPA's position regarding the Millennium legal matter. He provided comments regarding the asset management agreement and noted rent risks. He also reiterated his discontent of the Project Labor Agreement.

Dennis Turchon, TJPA Senior Construction Manager, and Ron Alameida, Director of Design and Construction, presented the update with Scott Boule, TJPA Legislative Affairs/Community Outreach Manager, who presented the status of transition tasks.

Director Reiskin urged the Executive Director and staff to continue to seek regional funds for this regional project. CFO DeBord confirmed that the team is working with MTC.

18. Presentation of the Draft Retail Plan for the Transbay Transit Center.

Martha Velez, TJPA Facility Manager, introduced Erika Elliott, Ann Natunewicz, and Julie Taylor of Colliers, with the Asset Manager team, who presented the item.

Vice Chair Gee inquired as to how local would be defined and how success would be measured. He stated to be prepared to present a metric and ensure local businesses are represented as the Board has stated is their interest.

Director Harper inquired on tenant improvement allowances and budgets. He also provided comments on pop-ups and experiences near his office in downtown Oakland.

Director Reiskin advised Executive Director Zabaneh to call Special Meetings if necessary due to the timeline for items that require Board approval. He encouraged engaging expert peer reviews as necessary. He reiterated the need for a strong local feel for the retail and to ensure all people feel welcome.

Chair Nuru echoed the other Directors and encouraged the team to go into the neighborhoods to reflect the community in the retail plan.

Public Comment:

Jim Patrick asked Directors to speak into the microphones as he had difficulty hearing. He suggested TJPA legal draft a standard lease. He also made suggestions for cross-promotions, and marketing in addition to incentivizing the retail people to get job done.
