The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) which contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendix designating positions and establishing disclosure categories shall constitute the conflict of interest code for the **Transbay Joint Powers Authority** (Authority).

All designated officials and employees must file their statements of economic interests electronically with the **Fair Political Practices Commission** and will be made available for public inspection and reproduction under Government Code Section 81008.

#### PUBLIC OFFICIALS WHO MANAGE PUBLIC INVESTMENTS

The following positions are not covered by the conflict of interest code because they must file statements under Section 87200 and therefore are listed for informational purposes only:

Members of the Board of Directors and their Alternates Chief Financial Officer

An individual holding one of the above listed positions may contact the Fair Political Practices Commission for assistance or written advice regarding their filing obligation if they believe that their position has been categorized incorrectly. The Fair Political Practices Commission makes the final determination whether a position is covered by Section 87200.

Such determination shall include a description of the consultant's or new position's duties and, based upon that description, a statement of the extent of disclosure requirements. The Executive Director's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code.

#### **Disclosure Categories**

- 1. Designated positions in this category shall disclose investments and business positions in business entities, sources of income (including receipt of gifts, loans and travel payments) and interests in real property.
- 2. Designated positions in this category shall disclose investments and business positions in business entities; and sources of income (including receipt of gifts, loans, and travel payments), from sources engaged in transportation (e.g. rail, motor, bus), tourism (e.g. restaurants, hotels, retail shops) as well as other sources of services (e.g. environmental, engineering and architectural consultants), supplies, materials, machinery, or equipment of the type utilized by the agency.
