Authorizing the Executive Director to execute a professional services agreement with Stantec Consulting Services, Inc. to provide archaeology services relating to Phase 2 of the Transbay Program, now known as The Portal, for a five-year base term, with the option to extend the term for up to three additional one-year terms, and an amount not to exceed \$1,192,525 for the base term.

Anna Harvey, TJPA Deputy Project Director for The Portal, presented the item.

10. San Francisco Peninsula Rail Program Executive Steering Committee (ESC) Update and status of the Downtown Rail Extension/The Portal Workplan schedule.

Michelle Bouchard, ESC Chair, provided the ESC update and Alfonso Rodriguez, TJPA Project Director for The Portal, presented the status of the schedule.

Public Comment:

Roland Lebrun noted Caltrain's most recent award of funding for battery electric multiple Visual Memory Unit (VMU) should be excluded from the Master Agreement with TJPA. He further noted there may be concerns with the Federal Transit Administration regarding potential ridership levels of the extension moving forward. Additionally, Mr. Lebrun stated that there is no statutory requirement for the High-Speed Rail authority to be included in the Transit Center and suggested integrating Caltrain as a transportation method with Google maps. Lastly, he suggested coordination with Link21.

11. Presentation of the Downtown Rail Extension/The Portal Procurement Approach.

Alfonso Rodriguez, TJPA Project Director for The Portal, presented the item.

Director Lipkin noted that the Project Team should ensure sufficient contract management and agency resources to oversee the work being performed as well as the multiple procurements, contracts and support contracts that will be issued.

Director Forbes inquired if prior performance will be considered during the Request for Qualifications or Request for Proposals. Mr. Rodriguez stated that elements will be evaluated during the Request for Qualifications in order to establish a benchmark of qualified firms.

Director Tumlin inquired whether there is a current mechanism to check references for all projects in a specific time period including all local work completed. Mr. Rodriguez responded that he will coordinate with the Project Team at their next weekly meeting to further discuss.

Director John-Baptiste inquired on the Project Team's process to evaluate personnel during the qualification process and assurance of long-term commitments including previous experience of contractors with subcontractors and the materials provided. Mr. Rodriguez stated that it is an on-going process that is conducted during contract documents and noted there are contractual mechanisms to hold contractors responsible, including succession planning. He further noted that there are numerous considerations the team is currently going through in the contract model.

Chair Gee noted the succession plan is a critical component of the contracting process and inquired how to ensure the continuity of decisions being made in 2023 are carried over into 2025. He emphasized the importance of prequalifying based on recent experience is critical. Chair Gee further noted a target price, or a range price should be included for full transparency and to give thought to providing additional points to bids that are near the target price.

Public Comment:

Roland Lebrun noted a different Value Engineering solution during the pre-proposal phase may be the solution to deliver the project at a lower cost. He also stated he supported Director Tumlin's comment to coordinate with the San Francisco Municipal Transportation Agency Central Subway team regarding lessons learned. ADJOURN – Chair Gee adjourned the meeting at 10:30 a.m.
