# **AGENDA**

#### 1. Call to Order

Chair Larkin called the meeting to order at 5:32 p.m. Based on a staff request, Chair Larkin called for a motion to move Agenda item 7 to occur after item 4 and before item 5, Member Nachor seconded, and all members present approved the motion.

Members Absent: Gabriel Chan, Pedro Mendez and Kia Kolderup-Lane.

2. Staff Report (10 minutes)

Lily Madjus Wu, TJPA Communications and Legislative Affairs Director, presented the Staff Report.

3. Approval of Meeting Minutes: March 11, 2025

There was no member of the public wishing to comment. Member Lavery motioned to approve the minutes; it was seconded by Vice Chair Shaw. A majority voice vote approved the motion. Member Woodmansee abstained.

4. Presentation by San Francisco Municipal Transportation Agency (SFMTA) on Updates to Service (15 minutes)

Jessica Garcia, SFMTA Service Planning Manager, presented the item.

Several members had questions and comments regarding the upcoming service updates, including questions on efficiencies in the SFMTA budget process relating to reducing operational costs and potential for increasing fares to offset service impacts.

#### **Public Comment:**

Jim Patrick, Patrick & Co, asked Ms. Garcia if SFMTA could request the City to decrease fuel and electrical costs to help alleviate the SFMTA funding crisis. He stated that public comment questions should be answered during public meetings.

## **Public Comment:**

Roland Lebrun discussed proposed future Caltrain fares at stations in San Francisco. He also noted that The Portal completion date has been pushed back from 2034 to 2035.

## 7. Election of Chair and Vice Chair

Member Shaw nominated Brian Larkin as Chair. Member Larkin accepted the nomination. Member Larkin nominated Brian Shaw as Chair. Member Shaw declined the nomination. There were no other nominations or members of the public wishing to comment. A motion to approve Brian Larkin as Chair was made by Member Shaw and Member Lavery seconded; it was approved by a unanimous voice vote of members in attendance.

Member Larkin nominated Brian Shaw as Vice Chair. Member Shaw accepted the nomination. There were no other nominations or members of the public wishing to comment. A motion to approve Brian Shaw as Vice Chair was made by Member Larkin and Member Thompson seconded; it was approved by a unanimous voice vote of members in attendance.

#### 8. Public Comment

Jim Patrick, Patrick & Co, stated that he asked a question of the SFMTA representative earlier in the meeting but was not provided an answer; he conveyed his disappointment with the policy to not respond to public comment questions as he believes the meeting should allow for public conversations to take place.

Member Mo stated that he was excited to join the CAC and looked forward to having an impact on local transit.
