## **Recent Accomplishments**

- Funding
  - MTC approved advancing The Portal through its Major Project Advancement Policy (MAP) from level 2 to level 1
  - MAP is a regional policy to support implementation of Plan Bay Area 2050+ aimed at delivering the next round of major transportation projects through a process of regional coordination to identify funding priorities
  - MTC's Regional Cap and Trade Framework includes Transit and Intercity Rail Capital Program (TIRCP) funding recommendations through its MAP endorsement



## **Recent Accomplishments**

- Delivery
  - Obtained Governance Blueprint Stage Gate 1 concurrence from Integrated Project Management Team (IPMT) and Executive Working Group (EWG) supporting release of Civil and Tunnel Progressive Design Build (40-CT) Request for Proposal (RFP)
  - 60% design packages were completed for both Caltrain Railyard enabling works contract (20-YA) and utility relocation on Townsend Street (10-UR) incorporating cost reduction scope changes



# **Current Activities**

- Environmental Assessment (CEQA/NEPA) work for cost reduction secondary mitigations
- Caltrain Concept of Operations study for the staging of work in and adjacent to the 4th and King Yard
- Development of 40-CT civil and tunnel contract RFP
- Design for track rearrangement in the Caltrain 4th and King Yard to connect with The Portal
- Stakeholder review for 60% design packages for 20-YA and 10-UR
- Advancement of Real Estate preparation activities
- Implementation of the Integrated Project Delivery Team
- Validation of updated Quantitative Risk Assessment Model



# Federal Transit Administration (FTA) Update

The FTA's Project Management Oversight Contractor (PMOC) February Monthly Report, included mention of:

- The recently executed Portal Project Implementation Memorandum of Understanding (MOU) provides for a collaborative, long term effort by the six agency stakeholders to address the project funding gap with specific advocacy priorities at the state, regional, and local levels.
- Program funding concerns have impacted the current Master Schedule, reducing the schedule contingency. TJPA has acknowledged that a full evaluation of the Master Schedule, including review and update of the required schedule contingency, will be conducted as the local funding picture becomes clearer.
