## **Anticipated DBE Participation Level (ADPL)**



- In accordance with Title 49 of the Code of Federal Regulations,
   Part 26 (49 CFR Part 26), the TJPA is required to implement a DBE Program to ensure nondiscrimination in the award and administration of U.S. Department of Transportation (DOT)-assisted contracts.
- As a recipient of DOT grant funds, the TJPA must establish a triennial goal for DBE participation in all new contracts planned to be funded with Federal funds.
- The next triennial period includes contracts anticipated to be awarded between October 1, 2025 and September 30, 2028.



## **Goal Setting Methodology**

#### Determine the market area for consultants and contractors

 Nine County Bay Area: Alameda, Contra Costa, Marin, Napa, San Francisco, San Mateo, Santa Clara, Solano and Sonoma

#### Determine work categories for anticipated federally funded contracts

- 1. Downtown Extension Main Civil Package Design & Construction
- 2. Downtown Extension Core Systems & Trackwork Design & Construction
- 3. Downtown Extension 4th & King Track and Systems Design & Construction
- 4. Downtown Extension Station Fit-Out Design & Construction



## **Goal Setting Methodology**

- Identify DBE firms ready, willing and able in market area using California's United Certification Program database of DBE certified vendors.
- Step One Base Figure

Step Two Adjustment to Base Figure

Step Two Adjustment to Base Figure = 
$$\frac{\text{Step 1 Base Figure } \% + \text{Median Past Participation } \%}{2} = 4.03\%$$



### FFY 2022-2025 Goal Setting

- Past practice included a two-step process to determine 17% ADPL for FFY 2022-2025.
- The contracts identified four (4) North American Industry Classification System (NAICS) codes to categorize the type of work anticipated for all work projects and was a high-level review of the work to be performed.

#### **Public Comment Period**

- A notice of the proposed DBE goal was published on the TJPA website on Friday, June 6, 2025.
- The proposed DBE goal was sent to the business community for input via notice to the Bay Area Chambers of Commerce, the Business Outreach Committee, and TJPA's project stakeholders and funders.
- Staff presented the proposed DBE goal to the Board during the June meeting.
- During the 30-day public comment period, no comments were received.



#### **DBE Next Steps**

- Now that public comment period has closed, Staff will request approval of the final DBE goal at the July 10 Board meeting.
- Once the final DBE goal is approved by the TJPA Board, staff will submit the goal to DOT by August 1.
