## **AGENDA**

### 1. Call to Order

Chair Larkin and Vice Chair Shaw were absent; therefore, Secretary Larrick initiated the process for a member to preside over the meeting. Member Thompson nominated Member Mendez to be Acting Chair for the meeting, no other nominations were made. A motion to elect Member Mendez as Acting Chair for the meeting was made by Member Thompson and seconded by Member Nachor. There was no member of the public wishing to comment. A unanimous vote approved the motion.

Acting Chair Mendez called the meeting to order at 5:36 pm.

### 2. Staff Report (10 minutes)

Lily Madjus Wu, Communications & Legislative Affairs Director, presented the Staff Report.

### 3. Approval of Meeting Minutes: December 9, 2025

There was no member of the public wishing to comment. Member Nachor motioned to approve the minutes; it was seconded by Member Chan. A majority voice vote approved the motion. Member Paterson abstained.

#### 4. Annual Progress Report & Plan for 2026 (30 minutes)

Ms. Madjus Wu; R.E. Walsh, Facility Director; Rodney Harris, Chief Security Officer; and, Alfonso Rodriguez, The Portal Project Director jointly presented the item.

#### Public Comment:

Roland Lebrun asked when the Program Management Information System would be available for public viewing, and he reported that when he first started paying attention to the Downtown Rail Extension program, fifteen years ago, they gave a guiding principle that there must be absolutely no impact to Caltrain operations.

#### 5. Public Comment

Roland Lebrun stated that Cap-and-Invest will be negatively impacted by the local refinery closures as 16-20% of the revenue comes from the refineries and commented on the California State Budget loan of \$750 million to Transit agencies to keep them operational until the passage of SB63.

#### 6. CAC Member Comments & Future Agenda Requests

Ms. Madjus Wu announced that some items from the Future Agenda Request list would be presented in the coming months as confirmations are made with project sponsors.

Secretary Larrick reiterated that the February meeting would be cancelled as Ms. Madjus Wu stated in item 2 and that he would officially distribute and post the cancellation notice later in the week.

Future agenda requests include: 1) San Francisco County Transportation Authority update on Southeast Railyard Station Study; 2) presentation on the Operating and Maintenance plan for the rail levels of the Transit Center; 3) presentation on Link21 and effects to The Portal; 4) presentation by SamTrans on their services at the Transit Center; 5) presentation by the San Francisco Municipal Transportation Agency on Bus Plaza bus departure times listed in information displays; and, 6) presentation by San Francisco Mayor's Transportation Advisor on the new administration's transportation priorities.

Acting Chair Mendez adjourned the meeting at 6:23 p.m.
