1. Call to Order

Chair Larkin called the meeting to order at 5:32 p.m.

Members Absent: Paul Bendix, Martin Munoz and Eric Schatmeier.

2. Staff Report (10 minutes)

Lily Madjus Wu, Communications & Legislative Affairs Director, presented the Staff Report.

3. Approval of Meeting Minutes: June 9, 2026

No public comment was received. Member Karnilowicz moved to approve the minutes, and Vice Chair Shaw seconded the motion. The motion was approved by a majority voice vote. Chair Larkin abstained.

4. Presentation by San Francisco Municipal Transportation Agency (SFMTA) on its Services and Priorities, including Mayor Lurie's Transit Priorities (20 minutes)

Alex Sweet from Mayor Lurie's Office and Jessica Garcia of SFMTA jointly presented the item.

There was a robust discussion amongst CAC members, Ms. Sweet and Ms. Garcia.

Public Comment:

Jim Patrick, Patrick & Co., stated that he did not believe the proposed revenue measures would pass and suggested implementing a ridership congestion pricing plan. He asked what the backup plan would be if the current plan failed.

Roland Lebrun stated that he believes the San Francisco parcel tax measure will pass. He asked how SFMTA plans to improve fare compliance, as referenced on slide 20.

5. The Portal Update and Monthly Status Report for June 2026 (15 minutes)

Alfonso Rodriguez, The Portal Project Director, presented the item.

Public Comment:

Roland Lebrun stated that maintaining separate project plans is no longer effective and suggested consolidating Link21, The Portal, and the Pennsylvania Avenue Extension into a single project connecting Emeryville and Gilroy. He also stated that it is time to pursue public-private partnerships to help fund the project.

6. Public Comment

Jim Patrick, Patrick & Co., suggested installing a large bank of monitors in the Grand Hall to display activities throughout Salesforce Park and the Salesforce Transit Center, stating that it would generate excitement and interest in the facility. He also recommended improving the visibility of leasing signage and actively recruiting a commercial real estate firm to help fill vacant storefronts.

Roland Lebrun discussed technical issues with Webex and the TJPA CAC's audio equipment and suggested deploying new microphones.

7. CAC Member Comments & Future Agenda Requests

Secretary Larrick noted that Future Agenda Items 5 and 6 would be removed from the list because they were addressed under current Agenda Item 4. He also reiterated that the regularly scheduled August 11 CAC meeting would be cancelled, as noted by Ms. Madjus Wu during Item 2.

Future agenda requests include: 1) San Francisco County Transportation Authority update on Southeast Railyard Station Study; 2) presentation on the Operating and Maintenance plan for the rail levels of the Transit Center; 3) presentation on Link21 and effects to The Portal; and 4) presentation by SamTrans on their services at the Transit Center.

8. Adjourn

Chair Larkin adjourned the meeting at 7:10 p.m.
